You must submit the application for the pause in garbage, latrine or/and sludge collection at least one month before the applied period. Otherwise, we can't grant you the application. If your application is for a vacation home, you must apply no later than April 1 of the first year you are applying for. The period of residence must be valid for a continuous period of at least six months for permanent residence and at least one full season for vacation homes. You can read about this in 34 § of the municipality's regulations on waste management.
